October Principals Report

1890 festival: We will be having our parking area for this year's event and will decide this week whether we will have enough volunteers to operate a booth as well. We are considering increasing the charge for parking to \$15. Our neighbor across the street is no longer operating a parking area. We will be selling bottled water at our parking area. We are asking for volunteers to sign up to volunteer their time at our parking area throughout the day November 5th.

Academic Update: We have completed the fall diagnostic assessments in line with the MCPS schedule. As part of our school improvement plan, we will analyze this data to guide our classroom instruction. During the teacher workday, we conducted our first data analysis workshop to incorporate the results of the assessments into the teachers' lessons. We currently have 10 students enrolled with IEP's who require either speech and/or OT services. We have contracted with a new speech therapist and the McIntosh OT group for services.

Fundraising and Marketing Update: A meeting took place to discuss fundraising and marketing strategies to promote and support MAS. We have scheduled a First Responders Day activity for Thursday October 27th and have invited numerous first responders from different community support services. Staff and students will prepare several activities to show our support and appreciation to our local first responders. The 1890's event and fundraiser was mentioned above.

Enrollment:

Our current enrollment is 54. The Breakdown is as follows: Kindergarten-(12); 1st (8); 2nd (12); 3rd(10); 4th (6); 5th(6)

Budget/bookkeeping: We have terminated our agreement with our previous bookkeeper as she moved into another position and have signed an agreement with Building Hope organization who has now assumed many of our bookkeeping responsibilities effective immediately. Candace is still performing the payroll tasks until Building Hope is ready to assume this task as well.

MAS Tutoring Program: Our after-school tutoring program has begun and meets Wednesday and Thursday afternoons for one hour. We have invited 14 students based on first round assessment data and classroom performance who would be most impacted from intensive tutoring at this time. We will continue to use the data to monitor student progress and invite additional students as space becomes available.

Afterschool clubs update: Our Runner's club operates on Tuesday afternoons from 2:50 to 3:50. Coach Tiffany has approximately 30 children from all grades participating and have also recruited several parent volunteers to assist her with this activity. Coach Don has also been a great support to Tiffany and has provided board visibility at this activity. Due to the new MCPS assessment schedule that we are following, several different mandated assessments were scheduled during the months of August and September. Therefore, we postponed starting the Art and Spanish Clubs until November

Title 1 Program: We held our annual Title 1 meeting on Thursday, October 6th with approximately 25 families represented. We identified the services provided to our students and families through Title 1 and discussed the Parent and Family Engagement Plan and the Parent - School Compact. We also have the results of the recent family survey. Our Book Character Day is scheduled for Friday, October 28.

Facilities Update: We needed to repair a section of the 5th grade room floor due to moisture. This was a similar problem that we experienced in the 4th grade during the summer as well as in the cafeteria. According to Servpro, Flooring project contracts were sent to the Town of McIntosh in September but have not been signed and returned to Servpro. We are waiting on quote for the installation of sunshades on the playground area.



Curriculum Overview

- Classroom instruction is based on the expectations identified in the Florida State Standards aligned with B.E.S.T.
- * We use the following curriculums to meet the needs of our students:
 - ELA: MyView Literacy for all grades Kindergarten through grade 5. This program contains phonics, phonemic awareness, comprehension, and writing skills. Additionally, students will be utilizing the interactive platform on their 1:1 devices.
 - Math: Envision Math for all grades Kindergarten through grade 5. This program includes an interactive element to
 increase student engagement and to better prepare the students for assessments they will be taking through
 STAR/FAST in accordance to the Florida State guidelines throughout the year that are computer based assessments.
 - Science: Science weekly curriculum is being utilized for all classrooms in both print and digital format Additionally, 5th grade students are following the curriculum as outlined in accordance to state standards to prepare for the Spring Assessments.
 - Social Studies: We use Florida Studies Weekly in both print and digital format to teach social studies topics that are relevant to each grade.
